1. Badhaiyatal Rural Municipality towards the construction of various works inside this rural municipality and intends to apply part of the funds to cover eligible payments under the Contract as mentioned below.
2. Badhaiyatal Rural Municipality is the implementing agency and invites electronic bids from all eligible bidders for construction of projects as mentioned below under National Comp.

4. Bidder who chooses to submit their bid electronically may purchase the soft copy of the bidding documents as mentioned above or may down load the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np. Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

6. Bidders are required to specify the total price of the Bid in the Letter of Bid or the Bid Price in the Bill of Quantities. Failure to specify the total price of the Bid in the Letter of Bid or the Bill of Quantities shall be ground for declaring the bid non responsive.
7. If the last date of pre-bid meeting, purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. The bidder may bid for any or all of the contracts invited in the IFB. Bidders, bidding for more than one contract will so indicate in their bid, together with a statement regarding any discount / cross discounts offered, but the Employer may approve the bid for one or any least cost combination of contracts subject to bidders meeting the qualification. The bidder should meet the qualification criteria separately for each Bid and in aggregate as stated in the Instruction to Bidders.
9. Matters not covered by this notice shall be in accordance with Public Procurement Act-2063 and public Procurement Regulations-2064 and other prevailing regulations.

10. The employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
